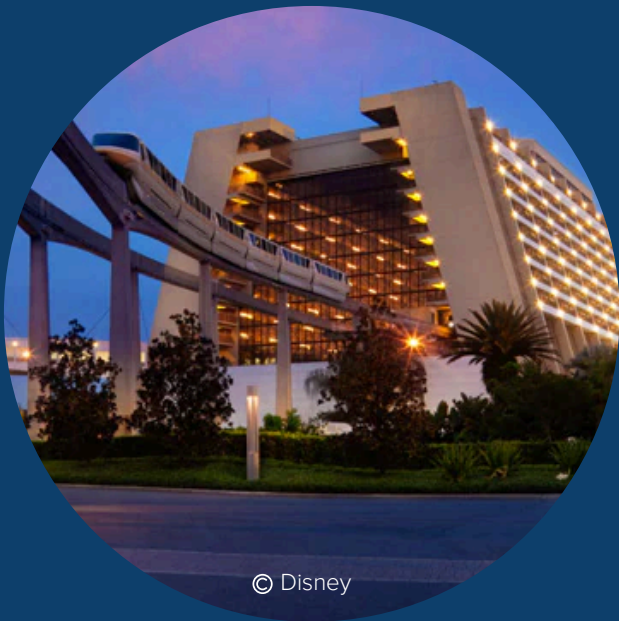
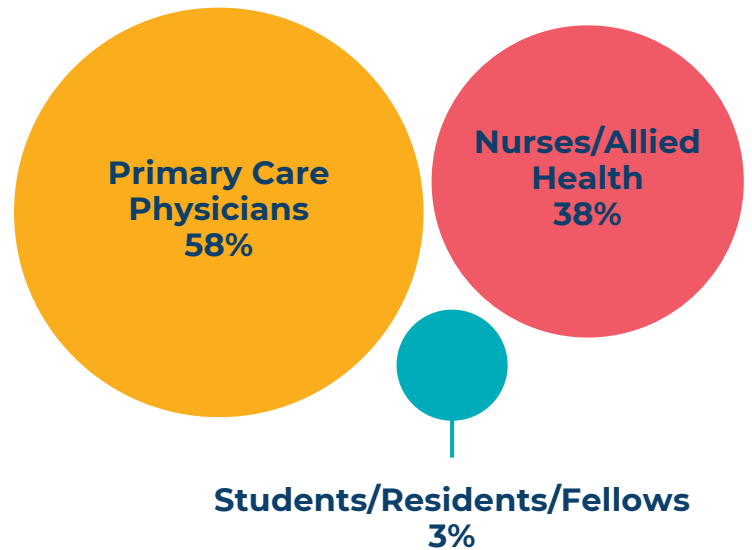

## Exhibit Description

Included in the cost of each exhibit is a 6' x 30" table with two chairs. Additional tables are available through the conference upon request, based on space availability and for an additional fee. Freestanding displays are permitted if dimensions have been submitted to conference staff in advance of the conference and approved.
